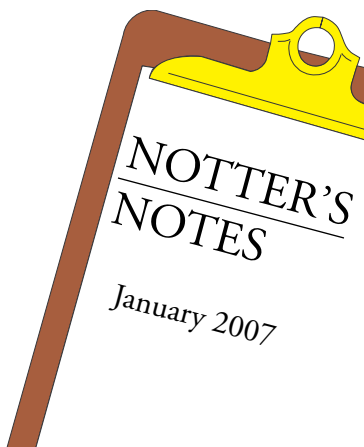
I am sure there are issues that need to be dealt with. I think these are the most important.

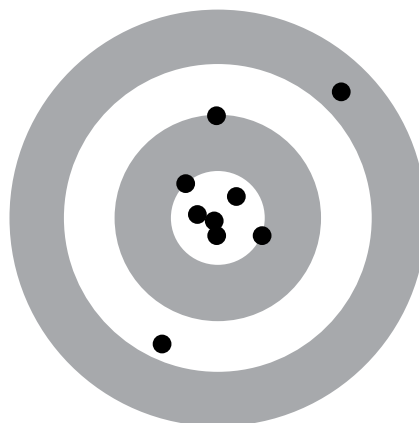
You are eligible to enter the Christmas drawing for gift certificates every time you attend a Member's General Meeting. There is no cost to enter.

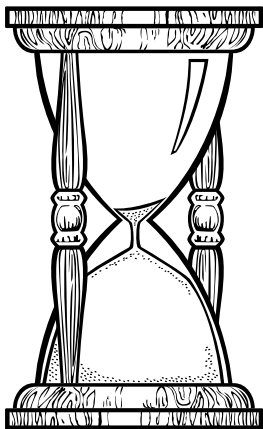
LEFT THE RANGE

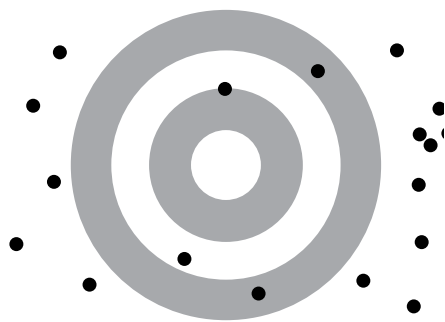

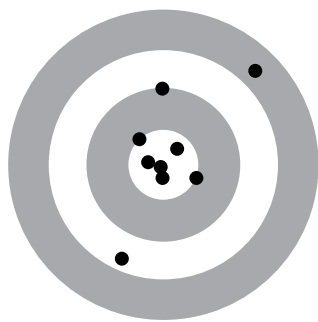

Provision Authored by Senators Boxer and Feinstein Will Exterminate All Santa Rosa Elk and Mule Deer

Wednesday, November 15, 2006

Fairfax, VA – Last month, President George W. Bush signed the 2007 Defense Authorization Act, which included an NRA-supported provision saving hundreds of elk and mule deer on Santa Rosa Island from the court-ordered extermination that was to begin in 2008 and be completed by 2011.

However, yesterday, Sens. Barbara Boxer and Dianne Feinstein attached an amendment to the Military Construction Appropriations bill that will overturn current law and exterminate hundreds of healthy elk and mule deer on Santa Rosa Island, off the coast of California. This issue is not about public access or whether these animals should be hunted and by whom. Current law protects the Santa Rosa elk and deer from extermination and this amendment will require that the animals be exterminated by 2011.

NRA-ILA Chief Lobbyist Chris W. Cox stated, “In a blatant attempt to slaughter these animals – for absolutely no good purpose – Senators Boxer and Feinstein claim to, ‘correct a terrible mistake’. The only irreversible mistake in this situation is if these elitist politicians are allowed to kill healthy and robust animals for political purposes.”

Santa Rosa Roosevelt elk and Kaibab mule deer are unique and invaluable, as they are free from Chronic Wasting Disease (CWD) and other ailments that threaten the species on the mainland. Forty miles of Pacific Ocean offer them a sanctuary from disease. The healthy and thriving herds can be used as breeding stock to repopulate in case of disaster on the mainland.

Cox concluded, “This is not about hunting – this is about political pandering and payback. The NRA is calling on Congress to not allow Sens. Dianne Feinstein and Barbara Boxer to kill hundreds of healthy elk and mule deer – for no good reason.”

Election 2006 Re-Cap

On November 7, 2006, the American electorate took out its frustration and anger on the Republican Party and turned over control of Congress, not to mention governors’ mansions and majorities in several state legislatures, to the Democrats. Importantly, however, on a day that saw voters expressing dissatisfaction over conduct of the war, over political corruption and over competency to govern, Americans cast their votes for record numbers of pro-gun candidates, both Democrat and Republican.

Many of the newly elected office holders pledged their support of the Second Amendment while on the campaign trail. They got elected when voters took them at their word. Those same voters, which certainly include first and foremost NRA members, will be closely watching them to make sure they walk the walk as well as talk the talk. NRA will make sure opportunities for tests of true intentions are not long in coming.

Change in Washington, D.C., will be very real. Extreme opponents of our Right to Keep and Bear Arms have been elevated to seats of power, especially in the House of Representatives, where Nancy Pelosi will become Speaker and John Conyers is set to take over the powerful Judiciary Committee. Anti-gunners will also assume the chairs of important sub-committees. The power shift is balanced in part by the fact that Second Amendment champion, and former NRA Board Member John Dingell, the longest serving member in the House, is set to regain the reins of the Energy and Commerce Committee and will be a powerful voice for gun owners rights among his colleagues. Pro-gun Democrats will also chair some very relevant committees and sub-committees.

There will be battles ahead, and, with the 2008 elections on the ever-nearing horizon, NRA members and their fellow gun owners must remain ever vigilant. We must let our representatives, both Democrat and Republican, know one thing: we expect our Second Amendment rights to be respected.

Hello, everybody. Now that the holiday season is history, we can all look forward to a fresh start and fresh attitude with much excitement for all of the new plans we have in the works for our Association. With the acquisition of our new lease we can expect great things to happen. Please remember that these changes will require the cooperation and efforts of all of you, not just a few. Don't sit back and have your ideas wasted. If you don't participate in the improvements, don't complain when they're done. Talk to any shoot chairperson, board member or just send a note to the P.O. box with your ideas. When you mail it in, please put the words "Range Committee" on the envelope. This will ensure that it will be directed to the correct committee.

Let's show some pride and consideration. When you're at the property and some other person(s) have left a mess, notify the Range Master on duty, but then take the time to clean it up yourself. Remember, safety and cleanliness go hand in hand. So, keep it safe by keeping it clean.

Members: Many of you have told the Range Masters that you are still a little confused about the new gate and how it works. Here are the gate procedures:

When you arrive at the property.

The keypad is triggered by pushing the number key (#) followed immediately by the gate combination printed on your membership card. { example: #1234} This process takes a few seconds to release the gate mechanism. Be patient and wait for the gate to open.

When you leave.

The gate has a sensor device to automatically open for exiting vehicles. To activate this device, you must pull your vehicle up just passed the yellow line which is painted on the ground or just beyond the yellow marker sign on the side of the roadway. The gate will then open automatically and will close itself after the last vehicle has cleared the area.

Range Masters: Remember that EF&GA is a private association and is only available to the current members and their two guests. Please do not be reluctant to ask for a current membership card and photo I.D. from any person(s) using our facilities.

Members: Each member has a responsibility to oversee that all safety rules and regulations are being adhered to by all persons using our facilities. Please do not hesitate to remind other participants on our property of safety requirements in the event you observe any violation. In the time it could take to search out the Range Master, you may find by offering a friendly reminder yourself you just might prevent damage to our property or possible injury to a person around the offender.

Range Master duty is very important. Please look for the new 2007 Range Master scheduling books in the first aid box in the trap Ramada. Let's make this a banner safety year by having range coverage during all operating hours. Range Masters and future Range Masters, let's make our New Years resolution to eliminate the OTRM letters on the calendar.

We would like to send a **huge** Range Master thank you to "Smitty" and his crew of volunteers for their tireless work on our new outdoor stage. This new "Martin-Johnson" outdoor stage will be much needed and enjoyed by all of us.

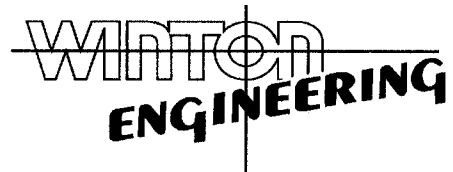

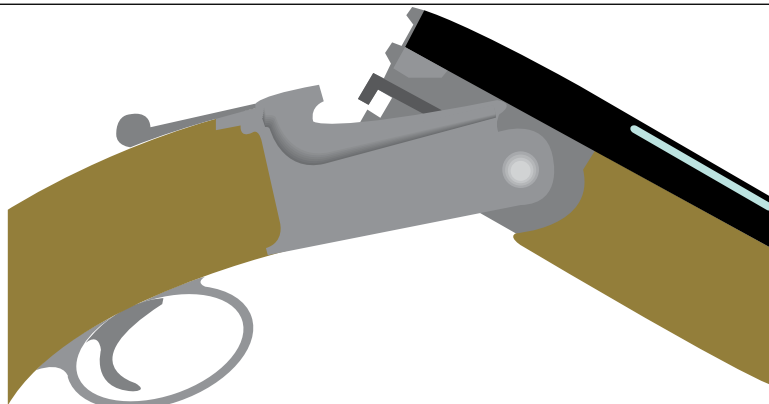
