This newsletter does not contain an editorial section and that is by design. We all have our opinions about politics, religion, nationalism, etc... However, this newsletter is not designed to be the vehicle for us to exercise our First Amendment rights, it is a document designed to inform the members of the Association of any items that may be of interest to them. With that stated, I encourage you to closely follow what our elected representatives are doing with our blood, our treasures and our rights. EF&GA is associated with the NRA and they have many resources on their web site (www.nra.org) with lots of information regarding current and pending legislation as well as major law suits going on at the state and federal levels. I'm not stating that we should all blindly follow whatever the NRA presents as the 'correct opinion', just that they are a good resource for information about what is happening at the moment in Second Amendment issues. If we are to present any strong arguments for or against any cause, we should start by educating ourselves on the issues in question. We should learn about the arguments on all sides of the issue and formulate our own opinions. It is important to learn as much as possible about the opposing side so that you can make a cogent argument that they cannot disprove. If you have a strong opinion for or against any legislation, I strongly recommend that you contact your elected officials at the local, state and federal levels and inform them that you (a voter) have a specific opinion about the issue(s). Sometimes our representatives need to be reminded that we are constituents of a democracy, not subjects of a monarchy. There are laws that define the regulation of ammunition commerce that went into effect January 1, 2018 (commerce via a DOJ licensed reseller/FFL in a face-to-face setting) with further restrictions that go into effect July 1, 2019 (instant background check and logging the transactions with DOJ at the time of sale). We just finished another great Junior Marksmanship event. The June 23, 2019 Junior Pistol match saw 17 shooters with 10 being first time shooters. This is the kind of event that I love to see. The more experienced shooters, on the first relay, battled it out for first place. Brayden Stansel scored a 393-18X and Daysha Halbert hit the mark with a score of 384-16X. Both took the Distinguished Expert titles. Austin Cote had a great showing with a score of 370, taking first place in the Expert category.

Overall, the new shooters did a great job. As I walked the line I looked for safety issues, as that is my number one priority in these matches. One of my biggest pet peeves is an undisciplined trigger finger. Putting the finger on the trigger when they are not looking through the sights, at the target is unsafe and I have been known to call a "cease fire" to go over the safety rules, when I see it happening too often. I can say proudly, that this was not the case today, as I saw only a glimpse of a bad trigger finger and it was quickly corrected by a Junior Coach. Additionally, I heard a lot of the coaches talking about proper trigger squeeze. A couple of the coaches even did trigger squeeze exercises, with their shooters, during the sight in period. This is one of the things that we teach in the Junior Marksmanship program. To put it simply, aiming is useless, if you don't have a proper trigger squeeze.

I would like to thank Eric Jamois, for taking the time to work with some of our newest adult coaches. Eric took the time to teach a couple new coaches the finer points of coaching for the Junior program. These new coaches went on to coach kids in the second relay. Judging from all the smiles of the faces of the kids and coaches, I think they did well.

The Junior Coaches program – This is what a future leader looks like.

TRAP CORNER

Trap Straights – Why We Do It

Shooting a trap straight is breaking all 25 targets in succession thrown for an individual by a trap machine during a single squad with an “official” score keeper. Breaking ALL 25 of them for the first time is more than just fun, it can be the fulfillment of a long and (often) agonizing path to personal success in a chosen, competitive sport/discipline. Every one of the people who are listed in our Trap Straights column have achieved a significant goal, but for those listed as 1st 25 STRAIGHT – SHOT HIS/HER HAT!!, it is the achievement of a pinnacle, a very memorable “first time in your life” moment that will never be repeated. This gets a little more complicated when you achieve a straight in other games. In Doubles, there are 13 pairs (26 birds) and that is a particularly challenging feat to accomplish. Getting a 25 in 5-Stand is almost impossible but every so often, someone does it. Just as rare is a 25 from Handicap (27 Yards behind the Trap machine). If you look at the list of Straights every month, you might notice some patterns emerge. We have some really good Trap shooters in our Association. If you want to improve your scores and perhaps even shoot your hat someday, it’s easy to figure out who to ask for pointers. Stop by any scheduled Tuesday, Wednesday or Saturday Trap event and see what the fun is all about.

InterClub Trap Competition (8/24/2019)

Don’t miss the InterClub match when we get to host the event at our range. There are categories for individuals (Men, Women, and Juniors) as well as a Team Score. The Team score is calculated by the average of the top 5 scores from each team and an additional ‘bonus-bird’ is added for each team member that shows up. Even if you don’t think that you are a great Trap shooter, you will still be helping our team just by showing up. You will shoot two rounds of 25 from 16 yards and two more rounds of 25 at Individual Handicap (distance calculated by your score in the first 2 rounds). The cost is \$30.00 for EF&GA members and \$35 for non-members and it includes lunch. Members and Guests ARE WELCOME. Sign-ins start at 8:00 AM and Shooting starts before 9:00 AM. 

RANGEMASTER SOUND OFF

It was bound to happen. You spend countless hours telling other people to be careful and not to do it. Years of training gone in a flash and others on the range are endangered with a few having to sit down to recover themselves after the ordeal!

I had the wrong type of target on the short pistol range and was called out by another RSO (and then they all started coming over)! I hang my head in shame and will perform 100 Tap, Rack and Clear exercises as penance. In my defense it was my guest's target and we had one tight hole in the middle and did not hit the wood frame and... Nobody is above the Association rules for safety, even me.

Concealed Carry has become more commonplace because the San Diego Sheriff's department is accepting a broader range of Good Cause statements. This is a good thing, but also brings some Safety issues to consider especially at the range.

Concealed means "concealed" and physically leave it there! Please DO NOT remove your loaded holstered firearm to show "Bubba" or take it out to practice with, then reload and holster again.

If you want to practice with your carry firearm(s), bring them unloaded in a range bag as you would any other firearm. We do have several shooting activities where you can draw from a holster and perform live fire at paper and steel targets.

As I mentioned concealed carry has become more commonplace in San Diego County and besides the physical aspects of carrying a firearm there are other things to consider.

I am not a lawyer, but you need to understand the legal aspects of carrying and the use of deadly force or brandishing (this is not TV or the Movies). You have to suck-it-up and walk away from a non life threatening confrontations and no more road-rage! Remember every bullet down range has a lawyer behind it...

What about the financial aspects of using deadly force because you feared for your safety? Do you have or know a lawyer knowledgeable in defending firearms cases? Do you have personal Concealed Carry insurance to help pay the egregious costs associated with using a firearm?

In my opinion the most important point to consider about Concealed Carry to defend yourself or your family because you feared for your safety is; do you have the mindset to pull the trigger?

To help with these decisions you need training and practice on how to deal with these situations and to be SAFE carrying a firearm on a daily basis.

We have several outstanding shooting events that are not necessarily self defense in nature but they allow you to become familiar with your firearm(s), handle stress, deal with malfunctions and to gain muscle memory by shooting. Most importantly, they are FUN!

Once again, I am looking for those of you that want to "sacrifice" and volunteer to become a Range Safety Officer. Do you have the right "mindset" to help keep our range safe from all these crazies with Concealed Carry permits...

Cold Range:

- Blue Blinking Lights **ON**
- **DO NOT** handle Firearms & Equipment
- Handle Targets
- Sweep up brass behind the Yellow and in front of the Red line

OK TO GO DOWN RANGE

Hot Range:

- Blue Blinking Lights **OFF**
- Handle Firearms & Equipment
- OK to Load/Unload Vehicle
- Sweep up brass behind Red line

DO NOT GO DOWN RANGE

How to place a classified ad in the newsletter

Please help to keep the classified section easy to read and well organized. There is no cost as long as you are an EF&GA member in good standing. Classified ads run for ONE newsletter (one month). If you want to repeat an ad for another month (with price adjustments, etc...) simply re-submit the ad request via e-mail.

Please submit requests for classified ads via email to newsletter@escondidofishandgame.com and be sure to double-check for spelling and grammar errors.

Members Only are allowed to submit Classified advertisements. Your Membership Number must be included with any advertisement request so that we can properly vet the submission before it is published. The Membership Number will NOT appear in the advertisement. Your Membership Number is on your membership badge on the same side as your photo.

No Illegal Transactions may be advertised in this newsletter. It is now illegal to sell ammunition in California without either going through an FFL or a licensed ammunition reseller. EF&GA cannot facilitate any illegal commerce of a state regulated commodity. This is also why firearm sales should include a phrase similar to Buyer pays DROS when advertising the sale of a firearm.

It may sound obvious but requests for classifieds are frequently received with not enough information to be useful to a reader. **There are 5 main components of a classified ad:**

Category – Most classifieds fall into one of 3 categories, 'For Sale', 'Wanted', or 'Lost & Found'.

Subject/Title – This will appear in bold in the advertisement. This should be short (2 or 3 words) and concise.

Description – This is the body of the advertisement and can be a few sentences but not more than a paragraph. Abbreviations appear cryptic and are not recommended unless they are well known acronyms.

Price – A specific dollar amount as well as qualifiers give the reader important information. For example, "\$600 or Best Offer, Buyer pays DROS, Will consider trades"

Contact Info – This should be a name AND a phone number (including area code) and/or an e-mail address.

BLACK POWDER NEWS

Next Contest: Our July Event will be a standard Pistol/Revolver contest with targets at 25, 50, and 75 yards. The rifle contest will be a Mid Range with targets at 75, 100, and 125 yards. Pistol starts at 08:00 and rifle starts about 10:00.

The dog days of summer should be in full swing soon. For some reason this tends to slow down attendance at Muzzle Loading events. The dedicated among you should be aware that SPAR is running a Muzzle Loading Congress Trophy event for Rifle, Pistol, and Trade Gun, coming up on October 6th. You do not need to be a SPAR member to shoot in this BullsEye event. (BullsEye events shoot PAPER targets so you can see where you missed.)

Despite the heat, NOW is the time to start practicing if you want to improve your skills and move up the ranks. There is no better way to practice than to come out with the crowd and shoot the Silhouette contests. Get advice, get critiqued, and develop your skills while there is still time. After all, it's not raining anymore right?

Build to Fit : Are you comfortable with the rifle or pistol you're currently competing with? For a surprising number of people, the answer is "no". You may not be able to reach your full potential as a ML shooter if you are shooting a production rifle that does not fit you, or has a fast twist barrel not suited for round balls. You DO NOT need to be a master craftsman or gunsmith to modify your rifle. Like the AR platform, most ML rifles can be modified to suit your size, stance, or barrel twist. I have owned six Hawken style rifles over the last 40 years. Only one of them is still "stock". Of the production guns that I have owned, I have found the Thompson Center and Traditions rifle stocks to be too "short", and to lack enough "drop", to allow me to get my head to line up with the sights.

The solution to the problem is to replace the stock for more "pull" and "drop". This is relatively easy to fix by going to Pecatonica River Long Rifle Supply. They offer 80% inletted stocks for a variety of different production rifles. The fancy wood can be a little "pricey", but they also offer cheaper clear grain wood stocks at a reasonable price. (This is a good place to start.) Tired of the brass "furniture" on your rifle? Replace it with Iron Furniture that YOU can Blue or Brown. If you're a "Dandy", you can find German Silver for some applications. Replacement accessories like this can be found at Muzzle Loader Builders Supply, or Track of the Wolf.

As mentioned in an earlier newsletter this year, Midway USA has a limited supply of slow twist, (round ball), drop-in replacement barrels for Thompson Center rifles. In some cases, these can also be adapted to other manufactures Hawken style rifles that have a hook-breech arrangement for barrels of the same width and snail architecture.

Are you tired of breaking springs and parts on your old lock? Is your lock getting slower than your patience allows? L&R

New Ammunition Laws in California

Disclaimer – This article is NOT legal advice or an authoritative reference. It is an interpreted summary based on direction from the California DOJ to storefront resellers and some additional research from government web sites and other ammunition resellers.

As many of you may have heard, starting July 1st, 2019 there will be new laws going into effect that will make it tougher for law-abiding citizens to purchase ammunition in California. Thanks to Proposition 63, the called “The Safety for All Act of 2016” that was amended by Senate Bill 1235, Stats. 2016, ch 55, ammunition sales must be conducted in a face-to-face transaction by a current Federal Firearms License (FFL) holder or licensed Ammunition Vendor (AV). So far the guidance from the California DOJ has been very broad, at best. But I’m going to do my best to answer some of the questions that people have been asking me, lately.

The implementation of the law happens in two phases:

Phase I - Beginning **January 2018**, individuals and businesses will be required to obtain a one-year license from DOJ to sell ammunition. Certain individuals and businesses would not be required to obtain a license, such as licensed hunters selling less than 50 rounds of ammunition per month to another licensed hunter while on a hunting trip.

Phase II - Beginning **July 2019**, ammunition dealers will be required to check with DOJ at the time of purchase that individuals seeking to buy ammunition are not prohibited persons.

First, I want to start off with what is **not** in the bill.

1. There are NO purchase limits or caliber restrictions on ammo sales before or after July 1st. So you can buy as much ammunition as you want, in any caliber that you want and it doesn’t matter if you own a firearm that takes that caliber or not.
2. You must be a California resident to purchase ammunition in this state. So, if someone is visiting from out-of-state, they cannot legally purchase ammunition in California. Additionally, I have not seen any exemptions for military personnel that are stationed in California and do not have a California Drivers License or California Identification card.
3. There are no exemptions of current California CCW holders.
4. There are no restrictions on reloading components (primers, powder, projectiles, casings, etc.)

Starting July 1st, you will have to go through an ammunition background check. Think of this as a mini DROS or mini background check. This will include a \$1 fee per transaction and the collection of some personal information that will be used for the ELIGIBILITY CHECK. This will be done on the same system that is used to check your background for a firearm purchase. The only difference is that it will only take 2-3 minutes. I expect additional delays for the first few weeks as this system is sure to have issues at first. If you do not have a firearm registered in California, you may have to complete a more extensive, one-time, background check. This process will cost \$19 and will take a bit longer. If your California Drivers license or ID card has “Federal Limits Apply” on the front of the card, you will be asked to submit proof of lawful presence in the United States. The list of acceptable proofs of lawful presence is long and complicated but I will list a few of the more common ones:

- **Valid, Unexpired U.S. Passport or Passport Card**
- **Certified Copy of a U.S. birth certificate**
- **Certified copy of a birth certificate from a U.S. Territory**
- **Certificate of Naturalization or U.S. Citizenship**
- **Unexpired Permanent Resident Card**

Once you pass your Eligibility Check, you can purchase as much ammunition as your debit/credit cards can handle. It doesn’t matter if it’s one box or a thousand boxes, the fee to the state is the same.

Fun Fact: Starting July 1st 2019, all ammunition purchases will be recorded with the California DOJ. The data that is collected will be stored in a central database known as the Ammunition Purchase Records File. This database is to be kept secure and confidential and can be used for law enforcement purposes only.

The guidance by the DOJ was only given about 2 weeks ago. As you can see, these new laws are very complicated. I have tried to give you a quick overview of what is known as of today, June 23, 2019 at about 7pm. There is much more to the law that I have not included here, but the information that I have included is the most practical for the members of the Escondido Fish and Game Association. I’m sure that I will be getting more information in the coming days and weeks and I will try to keep everyone as informed as possible.
