IMPORTANT NOTICE TO ALL MEMBERS FROM YOUR BOARD OF DIRECTORS

At our December 7, 2006 Board of Directors meeting, a small group of members made a hostile attempt to take control of the EF&G Association's board using the Roberts Rules of Order as their ruse. We are happy to say their ruse did not work and your current slate of officers and board members has remained intact. However, in order that our entire membership understands the right and wrong of these events the board has engaged legal counsel to review and opine on the actions that have taken place.

Attached below, is an outline and legal opinion regarding these events.

The Affect of Robert's Rules of Order on the Operation of the Escondido Fish & Game Association

Dear Board of Directors:

This letter responds to the Escondido Fish & Game Association's request for a legal opinion concerning the affect of Robert's Rules of Order on the corporate governance of the Association. We understand that this issue has arisen because Article IV, Section 4, of the Association's Constitution and By-laws provides that "Robert's Rules of Order shall govern parliamentary procedure and the conduct of the Association on any point not specifically covered by the Association Constitution and By-laws."

The Association is organized under the Nonprofit Public Benefit Law and has elected to be governed by all the provisions of the Nonprofit Corporation Law of 1980. The Association has a Constitution and By-laws. Article XII of the Constitution and By-laws states that the By-laws are not intended to circumvent or violate any federal, state, or local laws, and in the event of a conflict, such laws shall prevail. The Associations' Bylaws appear to be consistent with the provisions of the Nonprofit Corporation Law of 1980.

It is well established in California that Robert's Rules of Order are merely procedural guidelines. As long as a nonprofit corporation complies with its bylaws and the law,

it need not strictly comply with Robert's Rules of Order, even when the nonprofit corporation has designated Robert's Rules of order as its procedural guidelines in its bylaws. When a nonprofit corporation's by-laws or constitution conflict with Robert's Rules of Order, the by-laws or constitution necessarily controls. Therefore, if the Board of Directors complies with the Association's Constitution and Bylaws, it is not required to comply strictly, or for that matter at all, with Robert's Rules of Order.

Article V, Section 8, of the Association's Constitution and By-laws gives the Board of Directors full control of the Association, including control over the Association's properties, the power to transact all business in the name of the Association and the power to adopt matters of policy on behalf of the Association. The Board's actions are final. Certain members of the Association have attempted to challenge the Board's actions through procedures purportedly outlined in Robert's Rules of Order. Members of the Association do not have the authority to challenge the Board's decisions through Robert's Rules of Order. As long as the Board of Directors has complied with the Association's Constitution and By-laws in good faith and has taken action the directors believe is in the best interests of the Association, neither the members of the Association, nor a court of law can second guess the Board's actions. This legal doctrine is commonly referred to as the "business judgment rule." Generally, the business judgment rule immunizes individual board members from personal liability for decisions of the board made in compliance with the nonprofit corporation's by-laws, in good faith and with the intent to serve the best interests of the corporation. The rule is justified on two primary grounds. First, the rule recognizes that directors should be given wide latitude in their handling of corporate affairs because the hindsight of the judicial process is an imperfect device for evaluating business decisions. Second, the rule recognizes that shareholders, or members in a nonprofit corporation, voluntarily undertake the risk of bad business judgment. In other words, no one is required to invest in a for-profit corporation, or participate as a member in a nonprofit corporation; people do so voluntarily. If members of a nonprofit corporation are unhappy with the decisions of the corporation's board of directors, they have the power to nominate and elect different directors in due course, or pursue

early removal of the directors pursuant to the procedures outlined in the Nonprofit Corporation Law.

Apparently, certain members of the Association have attempted to challenge the Board's decision to terminate the membership of Mr. Jeff Hawks through the use of Robert's Rules of Order. As explained above, members do not have the ability to challenge the Board's decisions through Robert's Rules of Order. The Board terminated Mr. Hawks pursuant to its powers under Article III, Section 13, of the Association's Constitution and Bylaws. Consistent with its authority under Article III, Section 13, the Board gave Mr. Hawks more than 15-days prior notice of the Board's decision to terminate his membership and advised him that he had a right to be heard at any time up to five days before the termination date. The Board even offered to hold a special session to allow Mr. Hawks to state his case. Mr. Hawks never responded to the Board's invitation, and the termination became effective on December 20, 2006. The membership should note that the Board complied with Article III, Section 13, in good faith, and that Article III, Section 13, is consistent with California Corporations Code section 5341, subdivision (c), which establishes fair and reasonable procedures for the expulsion, suspension or termination of members in a nonprofit corporation as a matter of law.

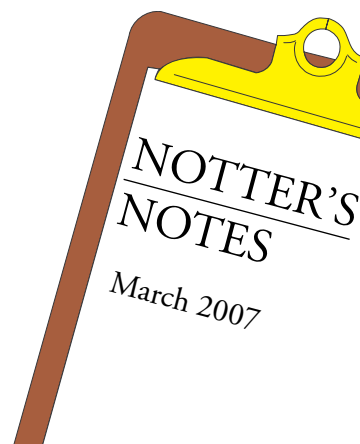

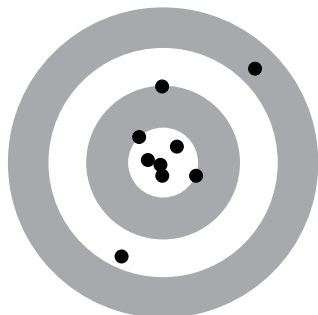

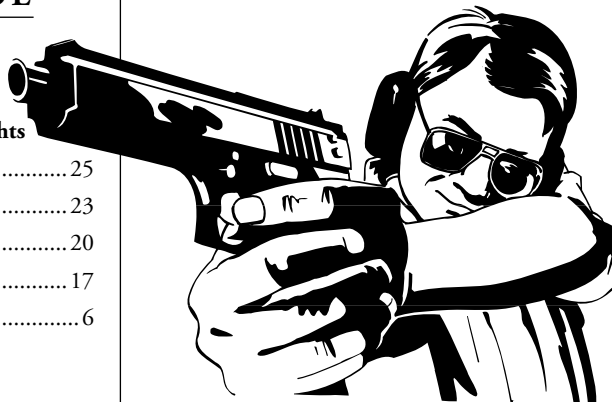

High-power rifle matches are held on the second Saturday of each month. Match start time is at 8:00 am. The Hi-Power Rifle Match has two separate courses of fire; a 100-yard 4-position match course and a 100-yard bench rest course. The 4-position match has prone, sitting, kneeling and offhand stages of fire. The bench rest course uses a front-end rest (i.e.: bipod) and the shoulder for a stock rest. Each match course consists of firing forty (40) rounds for score plus unlimited spotter rounds. Competitors may elect to participate in either or both matches. Entry fees are \$5.00 per competitor per match. Juniors under age 16 shoot free. Any legal center-fire, cartridge-firing rifle, regardless of caliber or action, is acceptable. Competitors may use open (iron) sights or rifle scopes. Slings are allowed except in the offhand position. No artificial supports are allowed in the 4-position course. Hearing and eye protection are required. The intent of the matches is to improve your skills and have fun while doing it. 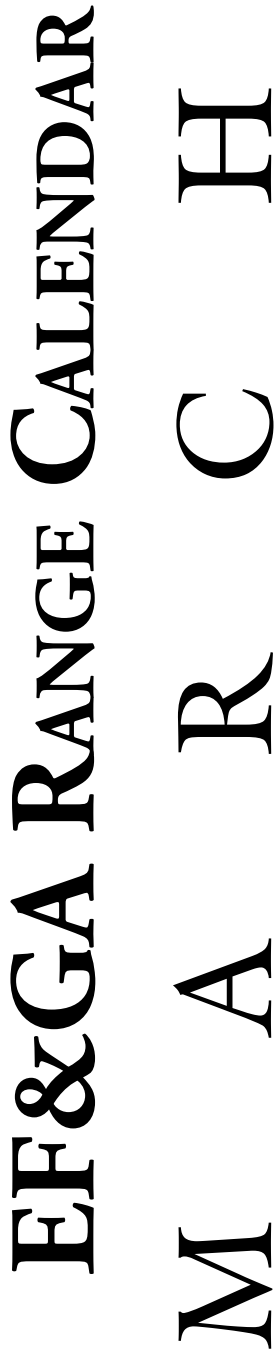

There seems to be a question about drinking alcoholic beverages on the property. Let us try to clear this issue up. Alcoholic beverages are allowed on the property; however, they are not allowed in the immediate vicinity of any firing range, (this includes the spectator areas). The rule is that there is no drinking of alcoholic beverages until you are finished shooting for the day. That basically means you finish shooting, pack up all of your firearms and equipment and then go on over to the trap Ramada, meeting hall or the picnic tables to enjoy your beverage.

The archery range is NOT a firearms range for casual shooting. The only allowable firearms shooting is during authorized match events, (Combat, IDPA, Cowboy) and only under the strict supervision of a shoot chairperson.

We find it extremely refreshing that while other ranges are falling by the wayside, our range, thanks to some wonderful volunteer helpers armed with picks, shovels, sweat and lots of positive energy, is showing vast improvements underway with the promise of more to come in the near future.

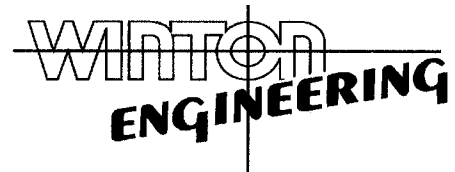

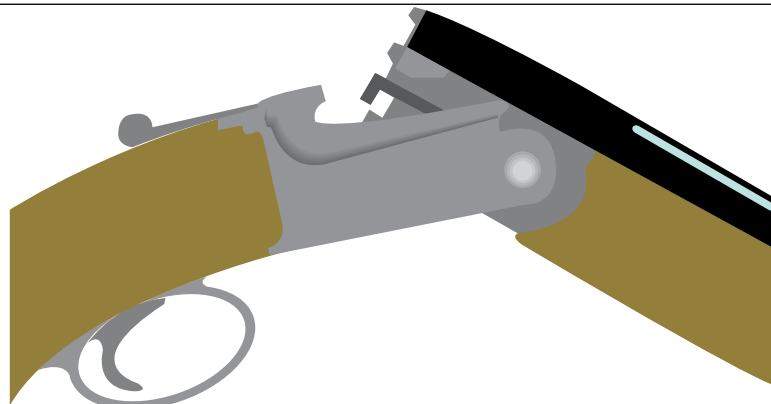
